CORRECTION DEED

KNOW ALL MEN BY THESE PRESENTS, that James D. Casteel and Margaret L. Casteel

in consideration of One Dollar ----- (\$1.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Christ Church, an eleemosynary corporation, its successors and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, containing 1.93 acres, more or less, being shown and designated as Lot 11 on a plat of River Ridge recorded in the R.M.C. Office for Greenville County in Plat Book 7-0, at Page 56, and having, according to said plat, the following metes and bounds, to-wit:
