the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THE COMMISSIONERS OF PUBLIC WORKS OF THE CITY OF GREENVILLE, S. C., their successors and assigns forever:

ALL water lines, mains, valves and appurtenances installed and located in, under or along South Wingate Road, North Wingate Road, June Lane and Midway Road, County of Greenville, State of South Carolina, including approximately 1,165 feet, more or less, of 6" C. I. pipe; approximately 3,660 feet, more or less, of 2" Galv. pipe; 3 - 6" Valves; 6 - 2" Valves and 1 fire hydrant and is shown on a drawing entitled "John P. Mann, et al, to Commissioners of Public Works of the City of Greenville, S.C., August 2, 1979", attached hereto and made a part of this conveyance.

TOGETHER WITH all other mechanical parts and equipment appurtenant to the said lines and all rights-of-way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.

This deed, along with a deed from Alfred C. Mann, Jr. prepared separately, conveys the full interest in said water lines, etc.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and assigns against the grantor(s) and the grantor's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
