KNOW ALL MEN BY THESE PRESENTS, that WE, Robert A. Bagwell and Carolyn Bagwell

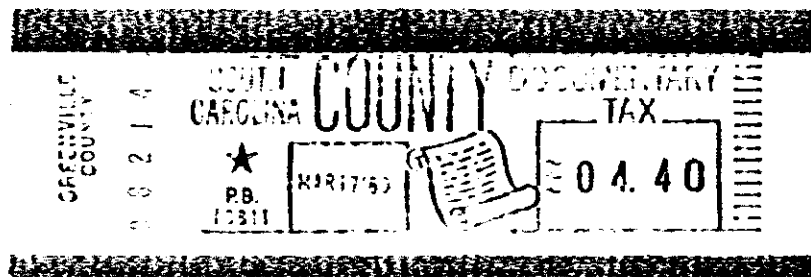
in consideration of Ten and No/100 (\$10.00) and other valuable consideration--- Dollars,

ALL that certain piece, parcel or lot of land situate on the West side of Cleveland Street Extension being shown as Lot 3A on a revised plat of Lot 3, Section E of Gower Estates recorded in plat Book 4C at page 87, the same being a portion of Lot 3, Section E, of Gower Estates as recorded in Plat Book BBB at page 71 and having according to the revised plat the following metes and bounds, to-wit:

BEGINNING at the joint front corners of Lots 2 and 3A and running thence S. 81-08 W. 379.8 feet to an iron pin; thence N. 21-11 E. 191.8 feet to an iron pin; thence S. 86-13 E. 298.3 feet which point is the joint front corners of Lots 3A and 3B; thence with the said Cleveland Street Extension S. 6-45 E. 102.5 feet to the point of the beginning.
