the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto MICHAEL A. McLAIN AND JANE T. McLAIN, their Heirs and Assigns forever:

ALL that certain piece, parcel, or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Creekside Road, near the City of Greenville, South Carolina, being known and designated as Lot No. 416 on plat entitled "Map 3, Section 2, Sugar Creek," as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7-X at Page 2, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Creekside Road, said pin being the joint front corner of Lots 416 and 417 and running thence with the common line of said lots S. 50-22-37 E., 139.4 feet to an iron pin, the joint rear corner of Lots 416 and 417; thence S. 19-06-48 W., 91.03 feet to an iron pin, the joint rear corner of Lots 416 and 415; thence with the common line of said lots N. 58-51-52 W., 165.16 feet to an iron pin on the southeasterly side of Creekside Road; thence with the southeasterly side of Creekside Road N. 35-22-45 E., 110 feet to an iron pin, the point of beginning.
