successors and assigns, subject to the provisions hereof, certain properties, more particularly described in SCHEDULE "A" attached hereto. Said properties, and any other properties which may hereafter be conveyed to the Trustees shall be held and managed in accordance with the terms of this Agreement.

ARTICLE II. DISPOSITION OF ASSETS. The Trustees shall hold and manage the trust assets, shall proceed with the orderly liquidation of the trust properties, shall collect the income thereon, if any, and shall distribute unto the Settlors, in equal shares, any and all net cash proceeds received by them, less such sums as may be reasonably necessary to meet anticipated trust expenses, such as taxes, whether such receipts be of principal or of income.

ARTICLE III. DEATH OF A SETTLOR. Upon the death of a Settlor, his or her interest herein shall pass in accordance with his or her Last Will and Testament, if any, or if none, to his or her heirs at law, subject, however, to the terms of this Trust Agreement. The successor or successors to a deceased Settlor's interest shall be entitled, collectively, to such deceased Settlor's share of payments or distributions made by the Trustees pursuant to ARTICLE II, ARTICLE V and ARTICLE VII herein.

ARTICLE IV. TRANSFER OF A SETTLOR'S INTEREST. Any Settlor hereunder may transfer, convey and assign any part or all of his or her interest hereunder at any time by duly signed written instrument, in recordable form, delivered to the Trustees. The assignee or assignees of any such interest, hereinafter referred to as "Successors", shall be entitled, collectively, to such portion of their assignor's interest as has been assigned to them and shall accordingly be entitled, collectively, to their proportionate part of their assignor's share of payments or distributions made by the Trustees pursuant to ARTICLE II, ARTICLE V and ARTICLE V herein.

ARTICLE V. REVOCABILITY. This trust may be revoked by notice of revocation signed by a majority of the Settlors, and upon receipt of any such notice, the Trustees shall thereupon
