the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Tom S. Bruce and N. A. Waldrop, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, as is more fully shown on a plat entitled "Property of N. A. Waldrop and Tom S. Bruce, Sr.", prepared by Jones Engineering Service, dated October 7, 1980, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the western intersection of Montgomery Avenue and Old Buncombe Road and running thence with the southwestern side of Old Buncombe Road, N. 31-04 W. 83 feet to an iron pin; running thence S. 56-26 W. 81.4 feet to an iron pin; running thence S. 33-30 E. 83 feet to an iron pin on the northern side of Montgomery Avenue; running thence with the northern side of Montgomery Avenue, N. 56-30 E. 86 feet to the point of beginning.

Manos died October 18, 1955 as is more fully shown in the Office of the Probate Court for Greenville County in Apartment 641, File 11. Under his will, he devised all of his property to Bessie Manos. Bessie G. Manos died December 10, 1979, as is more fully shown in the Office of the Probate Court for Greenville County in Apartment 1587, File 8. Under the terms of her Will, she authorized her Executors, Jimmy George Manos, Peter Andrew Leventis, and Andrew Leventis, Jr. to sell her property. This deed is executed by Jimmy George Manos, as one of the Executors pursuant to authority granted in said Will. This deed is given to correct that certain earlier deed dated May 29, 1980, recorded in the R.M.C. Office for Greenville County in Deed Book 1130, at Page (over...)
