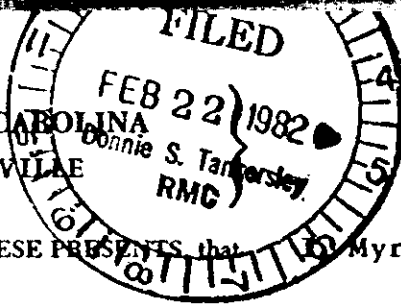

KNOW ALL MEN BY THESE PRESENTS that Myra McGee McMeekin,

in consideration of -----ONE DOLLAR AND LOVE AND AFFECTION----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

JULIA MCGEE BROOKS, her Heirs and Assigns, forever:

One-half (1/2) of ALL my interest in and to ALL THAT CERTAIN PIECE, PARCEL, OR LOT OF LAND with all improvements thereon lying, being and situate in the State of South Carolina, Greenville County, and in the Town of Fountain Inn, on the western side of North Main Street, and being more fully described as follows:

BEGINNING at a point on the northwestern corner of North Main Street and Fairview Street, and running along North Main Street a distance of 100 feet, more or less, to a point on the property line of now or formerly C. J. Jones Estate; thence turning and running along now or formerly Jones Property Line a distance of 383.24 feet, more or less, to a point on the Atlantic Coast Line Railroad right-of-way; thence turning and running along said right-of-way 115 feet, more or less, to the western side of Fairview Street; thence turning and running in a northeast direction along Fairview Street 330 feet, more or less, to the beginning point; and bounded by North Main Street, now or formerly property of C. J. Jones Estate, Atlantic Coast Line Railroad right-of-way, and Fairview Street. This being the same lot which for a number of years has been leased as a Texaco service station site and there is now on said lot a concrete filling station being operated by the A. E. Green Company, Inc., d/b/a Green's Service Station as Lessee (see R.M.C. Office, Greenville County, S. C., Deed Book 1032, Page 297).

THIS CONVEYANCE is made subject to rights-of-way, easements, conditions, public roads, and restrictive covenants, if any, reserved on plats and other instruments of public record, and actually existing on the ground affecting said property, and more particularly to the recorded lease referred to hereinabove.
