All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being at the southerly intersection of Hunting Hill Circle and Ladyslipper Lane, near the City of Greenville, in the County of Greenville, State of South Carolina, and being shown as Lot No. 564 on a plat entitled "Map Four, Section Two, Sugar Creek" recorded in the RMC Office for Greenville County in Plat Book 8-P, at page 62, and having, according to said plat, the following metes and bounds, to wit:
