reference to which is hereby craved for the metes and bounds thereof.

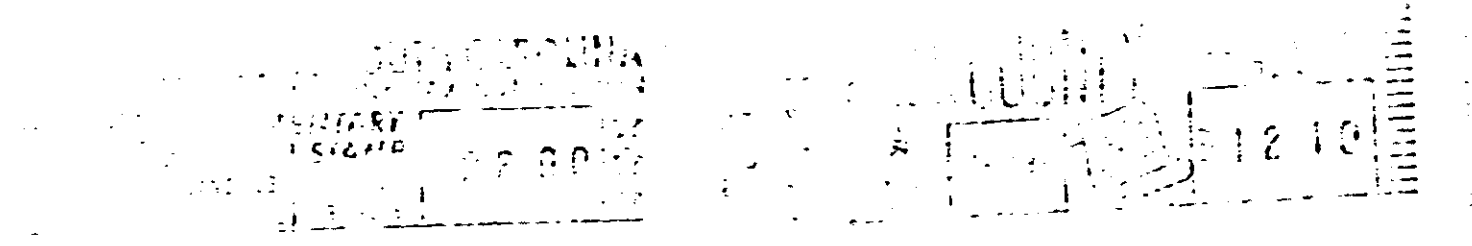
