All that piece, parcel or lot of land, situate, lying and being in which Spring's Township, State and County aforesaid, about two miles west from Greer, S. C. on the southwest side of North Buncombe Road (shown as Brannon Road on plat) and being shown on plat of property made for Peter and Majorie C. Sielinski by H. S. Brockman, Asst. Surveyor, dated December 25, 1959 as recorded in Plat Book SSS at page 262 in the R.R. Office for Greenville County. Said property is more particularly delineated and described as follows:

Beginning at northwest corner of tract on said plat identified as that of J. E. & Eudora Miller at iron pin on southwest side of said road and running with the western boundary of said tract S 33-05 E (125.6) feet to an iron pin; thence, S 55-18 E (40.7) feet to an iron pin; thence, S 22-45 E (41.0) feet to an iron pin; thence, turning and running S 45-00 E (90.0) feet to an iron pin; thence, turning and running N 42-45 E approximately (126.0) feet to an iron pin; thence, N 60-00 E (7.2) feet to an iron pin; thence, N 35-00 E (75.0) feet to an iron pin; thence, N 35-15 E (36.5) feet to an iron pin; thence, N 51-20 E (7.0) feet to an iron pin on the western side of the Old Buncombe Road; thence, N 64-10 E to the southern or southwestern side of North Buncombe Road; thence, turning and running along the western or southwestern side of North Buncombe Road (shown as Brannon Road on plat) to the beginning point herein described.
