in consideration of Thirteen Thousand and No/100 (\$13,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto M. Wayne Davenport and Dorothy B. Davenport, their heirs and assigns forever:

ALL MY RIGHT, TITLE AND INTEREST IN AND TO:

ALL that piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, in Dunklin Township, and on Line Creek waters of Saluda River bounded by lands belonging to J. H. Gaines, Frederic Bagwell, William V. Davenport and other lands belonging to Joseph R. Davenport containing twenty-five acres more or less, as follows:

BEGINNING at a stone on the head of what is known as the Thornton Branch, thence down said Branch to Line Creek; thence down said creek to a small black gum 111.x; thence N. 76 W. 29.90 feet to a stone 111.x; thence N. 7-3/4 W. 6.70 feet to the beginning corner.

ALSO:

ALL that tract or parcel of land containing 58.2 acres, more or less, in Dunklin Township, Greenville County, State of South Carolina, known as Davenport Place, located at the fork of the Honea Path Road and Dixie Highway about two (2) miles northwest from the Town of Princeton on the waters of Line Creek, bounded now or formerly as follows: on the north by lands of Clyde Kirby; on the east by lands of Berry Pressly; on the south by lands of Mrs. Nannie Davenport; on the west by lands of J.
