John Earle Forrester died intestate on February 6, 1978 survived by his two children aforesaid and his second wife, Helen W. Forrester, as will appear by reference to the records of the Probate Court for said county and state appearing in Apt. 1505, File 6.

Bertie S. Dill died intestate in 1981 survived by her three children, Iva Mae Dill Moon, Frankie Dill Taylor and John Earle Dill, her husband Frank Dill having predeceased her. No administration was made upon her estate.

Mary Alta S. Eidson died intestate in 1982 a resident of Anderson County, South Carolina survived by her only child, Sharon E. Young, her husband having predeceased her.

Henry Marvin Stokes, to whom a life estate in the above described property was conveyed by deed appearing of record in Deed Book 881 at Page 200 died intestate in March, 1982 survived by his brother, sisters, nieces and nephews as his sole heirs at law who have executed this deed and no administration was made upon his estate. Henry Marvin Stokes was never married.

All heirs at law and devisees of Thomas Merton Stokes and Hattie Louise Stokes have executed this deed with the exception of Earl H. Stokes who has executed a separate deed of conveyance to be recorded herewith.
