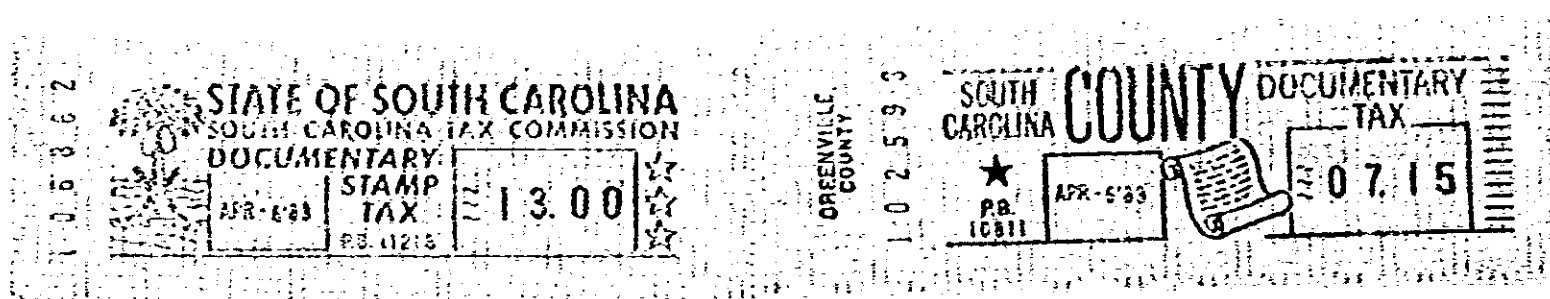
WARREN E. GUINN AND JO H. GUINN, their heirs and assigns, forever:
