

BEGINNING at an iron pin corner of Lot No. 1 on said plat, on the Southwest side of Judson Road, and running thence with line of Lot No. 1 S. 42-30 W., 200 feet to an iron pin in line of Lot No. 38; thence with line of said lot S. 53-55 E., 75 feet to stake, corner of Lot of Maggie Putman; thence with her line N. 42-30 E., 200 feet to stake on Judson Road; thence with Judson Road N. 53-55 W., 75 feet to the beginning corner.

PARCEL G

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the side of Rutherford Road, near the City of Greenville, and according to survey made by C. O. Riddle, on September 6, 1963, and being described as follows:

PARCEL H

BEGINNING at an iron pin on the Southern side of Boyce Springs Avenue at the Northwest corner of Lot 67, and running thence with the Southern side of Boyce Springs Avenue in an Easterly direction 167.5 feet to bend; thence continuing with the Southern side of Boyce Springs Avenue 138.5 feet to iron pin; thence in a Southeasterly direction 75 feet to an alley; thence along the alley in a Southwesterly direction 150.5 feet to pin; thence S. 35.5 East 75 feet to pin in line of 149; thence with the rear line of Lots G, F, E, D and C as shown on City Block Book, N. 61 West 371 feet to a point on Boyce Springs Avenue, the point of beginning.
