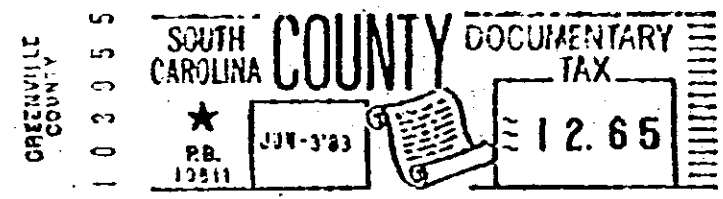
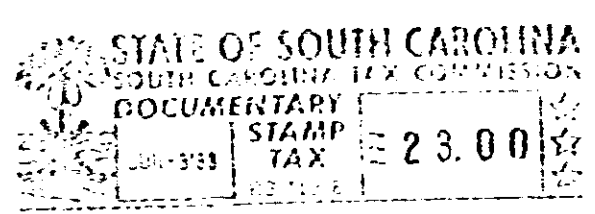
KNOW ALL MEN BY THESE PRESENTS, that Childrens Co., Inc.
