STATE OF SOUTH CAROLINA) DONN'S ATRÂNSFER OF SANITARY SEWER AND ASSIGNMENT OF RIGHTS OF WAY COUNTY OF GREENVILLE

KNOW ALL, MEN BY THESE PRESENTS: That the City of Greenville, South Carolina (Grantor) for and in consideration of \$5.00 paid by Western Carolina Regional Sewer Authority (Grantee), a body politic under the laws of South Carolina, the sufficiency and receipt of which is hereby acknowledged, does hereby assign, grant, transfer and convey unto the said Grantee, Western Carolina Regional Sewer Authority, its successors and assigns forever:

- 1. All of its right, title and interest in a sanitary sewer trunk line consisting of approximately 7,120 feet of 18-inch diameter sewer pipe and approximately 1,100 feet of 15-inch diameter sewer pipe, and all appurtenances thereto, including but not limited to marholes and marhole covers, beginning at an existing 21-inch diameter sewer near the intersection of Lowndes Hill Road and Arbutus Trial, then extending in a northeasterly direction to an existing 8-inch diameter sewer line near Azalea Court, as more fully shown on the recorded rights-of-way herein assigned to Grantee and listed in Paragraph 2, and as shown on engineering drawings by the City Engineer, File No. 24-8, dated Fe bruary, 1981. This is a newly constructed relief sanitary trunk sewer which closely parallels an existing 21-inch sanitary sewer. The parcels identified in Paragraph 2 below and on the referenced engineering drawings constitute all parcels in the project.
- 2. The following rights of way, heretofore obtained by Grantor and recorded as shown in the RMC Office for Greenville County, Greenville, South Carolina, are assigned and set over to Grantee, its successors and assigns:
