Pipe; 990 feet, more or less of 2" Galv. Pipe; three (3) 6" Valves' four (4) 2" Valves; two (2) Fire Hydrants; and seven (7) Valve Boxes as shown on a drawing entitled "American Service Corporation to Commissioners of Public Works of the City of Greenville, S.C.," dated December 21, 1983, attached hereto and made a part of this conveyance.
