Ben P. Woodside, Jr. and Martha B. Woodside, their heirs and assigns forever:

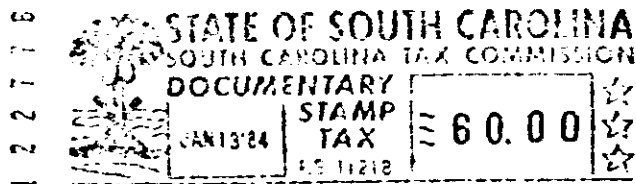
ALL that certain piece, parcel or lot of land known and designated as
