the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Martha Annelle Locke, her heirs and assigns, forever:

All our undivided one-fourth interest in all that piece, parcel or lot of land lying and being situate on the west side of Valentine Street, near the City of Greenville, South Carolina, being known and designated as lot 15, according to plat of Sterling College Park Addition, prepared by Dalton and Neves, June 1940, as recorded in R.M.C. Office for Greenville County, South Carolina, in Plat Book L, at page 171. Reference is hereby made to the said recorded plat for courses and distances.

This is the same property conveyed to P. R. Chiles by deed of Annie Ladd, dated March 26, 1956, and recorded in Deed Book 548, page 481, R.M.C. Office for Greenville County. P. R. Chiles died intestate on December 14, 1974. The grantors are the heirs at law of S. D. Chiles, and reference is hereby made to the Estate of Samuel Dyer Chiles, Apartment 1655, File 16, Probate Court, Greenville County, South Carolina. S. D. Chiles was a surviving brother of P. R. The other heirs at law of P. R. Chiles are conveying their three-fourths undivided interest to the grantee by separate deeds.
