The following Deed of Conveyance from William Floyd to John F. Wolff being given before Joseph Downs Esq^r. by the Oath of James M. Case was presented & recorded this 12th Day of Aug. 1795

State of S. Carolina } This indenture made this nineteenth Day
 Laurens County } of July One thousand seven hundred & ninety
 four } in the nineteenth year of the independence of the united States of
 America between William Floyd planter of the one part of the
 State aforesaid & County of Greenville & John F. Wolff Merchant
 of the other part of the State & County aforesaid. Witnesseth that
 the S. William Floyd for & in consideration of the sum of thirty
 pounds Sterling to him in hand paid by the S. John F. Wolff
 at and before the sealing & delivery of these presents the receipt
 whereof he doth hereby acknowledge, hath granted bargained & sold &
 by these presents doth grant bargain sell & deliver unto the S. John
 F. Wolff his heirs & assigns forever on full parcel or tract
 of Land containing two hundred Acres be the same more or less,
 Situate lying & being in the State aforesaid & County of Greenville
 on horse Creek a branch of Paddy River waters of Statute County six
 District bounding N. e. wardly on Land of M^r. Perry S. e. wardly
 on Land of M^r. Chandlers on other sides the names of the Land unknown,
 it being part of nine hundred Acres of Land surveyed for Wil-
 liam Wood the 10th Day of February 1782 & granted to the S. Wil-
 iam Floyd the 3rd of January 1795 by his Excellency Charles
 Pinckney Esq^r & C. (it having such shape form & marks touching
 & boundings as a plat thereof herunto annexed doth represent) together
 or withall & singular the premises & appertinances unto the S. John F. Wolff
 his heirs & assigns forever to have hold use occupy possess & enjoy without any inter-
 ruption or disturbance of the S. William Floyd doth hereby
