The following Deed from Shields Brother to William Jones being proven before John Blasingame Esq^r. by the oath of William M^r. Clapham was presented & Recorded this 26th day of January 1795

This Indenture made this fifth Day of January in the year of our Lord one thousand seven hundred & ninety five ^{or} of the Independence of the United States of America the Eighteenth between Shields Brother of the County of Greenville & State of South Carolina of the one part & William Jones of the County & State aforesaid of the other part witnesseth the said Shields Brother for & in consideration of the sum of fifty pounds Sterling money of the said State to him in hand
