

200 The following Deed of Conveyance from Tho<sup>s</sup>. Bell to Joseph M<sup>c</sup>Goughlin being proven before Rob<sup>t</sup>. McAfee Esq<sup>r</sup> by the oath of Joseph McAfee was presented & recorded this 28<sup>th</sup> January A<sup>d</sup> 1796

This Indenter made this <sup>both</sup> fifth Day of August & in the year of our Lord one thousand seven hundred & ninety five & in the nineteenth year of the Independancy of the united States of America Between Thomas Bell of the State of Carolina Greenville County of the one part & Joseph M<sup>c</sup> Goughlin of the Same State & county of the other part witnesseth that the S<sup>r</sup>. Thomas Bell for & in consideration of the Sum of Sixty pounds Sterling Money to him in hand paid by the S<sup>r</sup>. Joseph M<sup>c</sup> Goughlin at or before the Sealing & Delivery of these presents the receipt whereof the S<sup>r</sup>. Bell hath heuly acknowledge he the S<sup>r</sup>. Bell hath granted bargained & sold aliened & conveyed & by these presents doth grant bargain & sell alien & confirm unto the S<sup>r</sup>. M<sup>c</sup> Goughlin his heirs & assigns for ever a certain tract of land containing one hundred acres of land it being part of a tract of land granted to Thomas Bell by Joseph M<sup>c</sup> Goughlin Situated in the District of Washington lying the west Side of Spring creek of Enore river joining the tract of land which the S<sup>r</sup>. M<sup>c</sup> Goughlin now lives <sup>reference</sup> ~~where~~ being thereunto had may more fully appear together with all trees woods under woods tithes commons common waters water course of whatsoever to the S<sup>r</sup>. tract belonging or in any wise appertaining & also the reversion & reversions & remaines & remainders rights & services of the S<sup>r</sup>. premises & of every part thereof & also all the rights tithes Interest claim or Demand of them the S<sup>r</sup>. Thomas Bell or his heirs assigns the S<sup>r</sup>. tract of land containing one hundred acres & every part & parcel thereof to & to hold all & singular the premises above mentioned unto the S<sup>r</sup>. Joseph M<sup>c</sup> Goughlin & his heirs & assigns for ever & the S<sup>r</sup>. Thomas Bell for himself & his heirs the S<sup>r</sup>. Bell assigns will warrant & defend by these presents in witnes whereof the S<sup>r</sup>. Thomas Bell hath hereunto set his hand & Seal the Day & Date above written Signed Sealed & Delivered in the presence of
