The following deed of Conveyance from James Henderson to Jonathan Stone being proven before H. Cobb Esq. by the oath of Peter French was presented & Recorded this 19<sup>th</sup> day of April 1796.

This Indenture made the twenty ninth day of January one thousand seven hundred and ninety six between James Henderson of Greenville County South Carolina of the one part & Jonathan Stone of the County & State aforesaid of the other part Witnesseth that the said James Henderson for and in consideration of the sum of ten pounds current money to him in hand paid by the said Jonathan Stone the receipt whereof he doth hereby acknowledge & thereof exonerate & acquit the said Jonathan Stone his heirs &c. he the said James Henderson hath granted bargained sold aliened excepted convey and confirm unto the said Jonathan Stone his heirs and assigns for ever a certain tract of land containing seventy nine acres more or less situate lying and being in the County aforesaid on Mountain creek and Saluda River being part of Land originally granted to Tatum & Lafferty Court reference being thereunto had will more fully appear & bounded as follows to wit beginning on the said Creek at the mouth of abbing branch thence up said Branch S. W. 35° 8 chain & 50 links to a white oak thence S. W. 68° 9 chain & 75 links to a stake thence S. W. 8° 12 chain to a white oak thence N. E. 82° 1 & 10 links to a poplar thence S. E. 12° 8 chains & 50 links to the river thence down the said river S. E. 68° 9 chains & 22 links to Binsons Line, thence on the said line N.
