The following deed of Conveyance from Moses Lewis to George Lewis being  
 proven before James Kilgore Esquire by the oath of Isaac Green was  
 presented and recorded this 8<sup>th</sup> day of August 1796

This Indenture made this second day of May one thousand seven hundred  
 Ninety six and in the Twentieth year of American Independence between  
 Moses Lewis of the State of South Carolina Greenville County of the  
 one part & George Lewis of the State & County aforesaid of the other part  
 witnesseth that the said Moses Lewis for and in consideration of ten  
 pounds Sterling to him in hand paid by the s<sup>d</sup> George Lewis the receipt  
 whereof is hereby acknowledged the said Moses Lewis hath bargain  
 sold aliened & confirmed unto the said George Lewis for ever all that  
 Tract or parcel of Land containing 132 acres of land it being a part of  
 a Tract of 178 acres granted by patent bearing date the seventh day of  
 December 1795 & recorded in Grant Book F N<sup>o</sup> 5 page 533 reference  
 being had to a plat annexed to said Grant there being fifty acres of said  
 survey sold & conveyed to Peter Sarter & the land now to be conveyed  
 is all the land contained in said survey excepting said fifty acres con-  
 veyed to said Peter Sarter the balance being 132 acres including the  
 plantation whereon said George Lewis now lives & his land with all  
 its profits rents Issues commodities & appurtenances thereunto belonging  
 in any wise appertaining thereunto the said Moses Lewis doth  
 warrant & agree that he will for ever warrant & defend the said  
 land with all its appurtenances from himself his heirs Executors  
 Administrators & assigns or any other person whatsoever from  
 laying any Just or lawful right title or claim against the said George Lewis  
 thereof but to the only proper use & behoof of the said George Lewis  
 his heirs Executors Administrators or assigns for ever & lastly  
 the said Moses Lewis hath hereunto set his hand & seal & used his
