350 The following Deed of Conveyance from Eliha Dewees to Bryan Ward
Nowlin being proven before Thomas Campbell by the oath of Thomas
Bennett was presented & recorded this 6th day of April 1797
This Indenture made this seventeenth day of August in the year of our
Lord one thousand seven hundred & ninety four between Eliha Dewees of
Greenville County State of S. Carolina of the one part & Bryan Ward Nowlin
of the County & State aforesaid of the other part witnesseth that for & in considera-
tion of the sum of twenty five pounds lawful Sterling money to him the said
Eliha Dewees in hand paid by the said Bryan W Nowlin at ^{the} before the sealing
Delivering of these presents the receipt whereof he does hereby acknowledge
and thereof and every part & parcel thereof do acquit & discharge the said
Bryan W Nowlin his heirs & assigns for ever have given, granted, bargained,
sold, conveyed, & confirmed and by these presents do give, grant, bargain
sell alien, release, convey and confirm unto the said Bryan W Nowlin his
heirs and assigns for ever one certain tract or parcel of land situate lying
and being in Greenville County on a branch of reedy River containing
fifty three acres be the same more or less & bounded as followeth To wit
Beginning at a white oak corner where said Nowlins & Joseph Dunklins lines
Intersects thence S. along said Nowlins line 49 $\frac{5}{8}$ to said Nowlins corner
Aukery, thence the same course continued anewline & chains to a lightwood
stake, thence E 11. $\frac{5}{8}$ chains to a post oak, thence N 60 E 18 $\frac{7}{8}$ chains to a
lightwood stake in Joseph Dunklins line thence N 25 W along J. Dunklins
line 49. $\frac{1}{2}$ chains to the first mentioned beginning together with all houses
ricks, gardens, meadows, pastures, feeding fences, wood under ^{or} ways
waters & watercourses together with all the estate right title claim & demand
whatsoever of him the said Eliha Dewees in or the same or on any part of the
reversion & reversions remainder and remainders of all & singular the afo-
mented premises & every of their appurtenances to have and to hold the ³
fifty three acres of land (be the same more or less) & premises with their and
every of their appurtenances unto the said Bryan W Nowlin his heirs and
assigns to their only proper use and behoof for ever free & clear from all
Incumbrances whatsoever & further the said Eliha Dewees for himself his
heirs and assigns do covenant & agree to & with the said Bryan W Nowlin his
heirs and assigns that him with the right & title of the said land & premises
and every of their appurtenances against all persons or persons whatsover
will warrant & defend for ever unto the said Bryan W Nowlin his heirs &
assigns & lastly the P. Eliha Dewees his heirs &c. do promises & agrees to &
with the said Bryan W Nowlin his heirs & assigns that they shall & will be
ready at all times hereafter to make any deed or deeds conveyance or
conveyances as shall be requisite in the law for the better securing of the
right & title of the said land & premises unto the said Bryan W Nowlin his
heirs and assigns as he or they shall reasonably desire or require In
witness whereof the said Eliha Dewees has hereunto set his hand &
affixed his seal the day & year first above written
