The following Deed of Conveyance from Isaac Green to Elisha Simmonds being proven before Robert M'afee Esq^r by the oath of Joseph M'afee was presented and recorded this 7th day of June A^d 1797 389
This Indenture made the tenth day of November in the year of our Lord one thousand seven hundred and ninety six between Isaac Green of the County of Greenville and State of South Carolina of the one part & Elisha Simmonds of the aforesaid State & County of the other part, witnesseth that the said Isaac Green for and in consideration of the sum of ten pounds Sterling money to him in hand well & Truly paid by the said Elisha Simmonds the receipt whereof is hereby acknowledged he the said Isaac Green hath bargained and sold, and by these presents doth bargain & sell to the said Elisha Simmonds his heirs and assigns for ever in his actual possession now being a certain tract or parcel of land containing by estimation one hundred acres be the same more or less lying and being in Greenville County Including the plantation whereon the said Elisha Simmonds now lives it being part of a Tract of land Originally granted to the said Green by his Excellency Charles Pinckney Governor and commander in chief in & over the State of South Carolina said Grant bearing date the first day of October one thousand seven hundred and ninety one beginning at a lightwood Stake and running N. along W^m. Ryalls line about twelve poles to a pine corner thence a conditional by a gum tree to a black oak corner made by said parties thence to a black oak it being a corner of said Survey and a corner of Samuel J. Abston's Survey thence round with the line of said Survey to the line a branch between Elisha Smith and where said Simmonds now lives thence along said line to the beginning Including the plantation whereon the said Simmonds now lives which said Tract of land of one hundred acres be the same more or less with all and every of its appurtenances the said Isaac Green doth from himself his heirs and from all other person and persons whatsoever will warrant and for ever defend to the said Elisha Simmond his heirs and assigns for ever In witness whereof the said ~~Elisha~~ Isaac Green hath hereunto set his hand and affixed his seal the day and year above written
