 Gibson Southern being proven before John Tubb Esq. by the oath of Martin
 Dye was presented and Recorded this 9th day of June 1797
 This Indenture made the sixteenth day of November in the year of our
 Lord one thousand seven hundred and ninety seven between Robert M. Ape &
 Isaac Green of the County of Greenville and State of South Carolina of the
 one part and Gibson Southern of the said County & State of the other part
 witnesseth that the said Robert M. Ape and Isaac Green for and in
 consideration of the sum of fifteen pounds paid well & Truly by the said
 Gibson Southern the receipt whereof is hereby acknowledged the said Robert
 M. Ape and Isaac Green hath granted bargained sold aliened, released con-
 veyed and confirmed and by these presents doth grant bargain sell alien con-
 vey & confirm unto the said Gibson Southern his heirs and assigns for ever
