being on the Branches of mountain creek together with all and  
singular the rights members and appurtenances to the said premises  
Belonging or in any wise incident or pertaining to have and to hold  
all and singular the Premises before mentioned unto the sd Marick  
Bristo his Heirs and assigns forever and I do hereby bind myself  
My Heirs Executors & administrators to warrant and forever defend all  
and singular the sd Premises unto the said Marick Bristo his heirs  
and assigns and against myself & my heirs and against every person  
claiming from all manner of persons claiming onto claim any  
Part or parcel thereof as witness my hand and seal this second day of  
January in the year of our Lord one thousand seven hundred and Ninety Eight

The folowing Deed of Conveyance from Thomas McCarell to Epaphroditus Hightower being proven before Robert Cooke Esq.  
by the oath of Peter Cantrell was presented and Recorded this  
tenth of may 1798

This Indenture made this third day of December one thousand  
Seven hundred and Ninety seven between Thomas McCarell  
of the state of South Carolina and County of Greenville  
of the first part & Epaphroditus Hightower of the other part of the  
State and County aforesaid witnesseth for and in consideration  
of the sum of five hundred dollars to the sd Thomas McCarell  
in hand paid by the said Epaphroditus Hightower at or before  
the sealing and delivering of these presents the receipt whereof is

hereby acknowledged and there of and from every part and parcel thereof  
of doth hereby acquit the sd Epaphroditus Hightower by these presents  
hath granted bargained sold alined released and confirmed and by  
these presents doth grant bargained sell alien release and confer  
to the sd Epaphroditus He in his actual possession & to his heirs fore  
ever all that tract or parcel of land situated laying & being in the said  
County and State aforesaid on both sides of the Beaverdam Creek part  
of a survey granted to Ralph Smith and bounded as follows (272) begin  
ning on the side of the Mountain nearest the top on a Chestnut tree  
running N. E. Strait line 172 pole to white oak corner thence  
W. one C. W. Strait line 107 pole to a black gum corner thence S. W.  
Strait line 88 pole to dogwood corner including the upper mill  
Shole thence Strait line to the beginning corner Chestnut containing  
in one hundred acres more or less together with woods trees com  
modities emoluments preveleds and advantages what so ever to  
thesaid land belonging in any wise appertaining heres and profits  
of the said land with all the estate right and title claim and deman  
d what so ever both in law and equity of the said Thomas McCarell  
and his heirs or assigns of in or to the sd land and premises & to  
have and to hold the said one hundred acres of land hereby bargained  
and sold to the said Epaphroditus Hightower his heirs and assigns  
In fee simple in the here by granted and sold free and clear of all bur  
dens dowers rights and titles of dowers & that he the sd Epaphroditus  
Hightower his heirs and assigns may and shall hold occupy posse &  
enjoy the here by bargained & sold land with a warrant of the  
right and title of the said Land in fee simple to said Epaphrodi  
tus Hightower and his heirs forever the said Thomas McCarell do  
bind himself his heirs and assigns to Epaphroditus Hightower  
his heirs and assigns wifinal and full sum of one thousand dol  
lars In wit whereof the said Thomas McCarell have hereunto  
set his hand and seal the day and year first above written sign  
ed sealed and delivered In presents of us.
