 verance of these presents the Receipt there of is hereby fully
 acknowledged doth Grant bargain sell Assign Release and
 Confirm and by these presents doth Grant bargain sell Assign
 Release and Confirm unto him the said Peter Viece him his heirs
 and assigns for ever all that part of a certain Tract of Land
