County on Gray Creek of S^r Tyger River containing fifty Acres be the
same more or less it being a Part of a fore hundred Acre tract granted to
Archabald Dill and by Archabald Dill conveyed two hundred acres
unto James Copland and the said James Copland conveyed unto the
above Benjamin West and the said Benjamin West now has sold and
about to convey this part of the sd^r tract unto the said William Garbrough
supposed to be fifty acres as follow beginning on a Stake running 60^{ft} N^W
45^o E. to a Guard Chesnut thence a long the agreed line between
Gower and Copland to a post oak agreed on by us thence straight across
to the creek to a Chesnut agreed on thence Down the creek to the mouth
of the branch that heads up to the old school house thence up

and being in Greenville County and State aforesaid and on the south side of the
beaver dam creek of Tyger River adjoining Joseph Dill lands beginning
on a Iron wood ator near a branch running thence S^o 55^o E 18^o chains
to a black oak thence N^o 32^o W^o 14^o chains to a Chesnut thence South 70^o
W^o 11^o chains to a ~~maple~~ ^{chestnut} thence N^o 35^o E 31^o chains
to a State thence N^o 79^o W^o 34^o chains 50 Links to a maple at or
near a branch thence up the meanders of the Branch to the beginning
containing by Estimation one hundred and seven acres be the same more
or less being part a tract of three hundred and twenty three acres
