52 The following Articles of agreement ~~from~~ between Robert Cook & Elias Carle being proven before David Goodlett Esq^r by the oath of Daniel Kelley was presented and Recorded this 30th Day of June 1798
But Remembered that on the 8th Day of February 1798 that Elias Carle bargained and sold to Robert Cook Esq^r a tract of three hundred acres of land on the North fork of Saluda originally granted to James McElhenry & sold by McElhenry to Elias Carle as by reference to the records of the County will more fully appear, and it is further agreed on between the said Carle & Cook that if any other claim or title should by any means whatsoever take or Disprove the said Cook of the said tract then the said Carle shall refund the purchase money again and give the said Cook a power of attorney to sue & Recover of the above named McElhenry in his name all Costs and Damages that the said Cook may be intitled to by law & this is considered as to exonerate the said Elias Carle from any further trouble or Damage only to pay back the six hundred Dollars as the purchase money given under the hand & seal this day & year above written signed sealed and Delivered in presence of

53 by William Peden of Greenville County State of South Carolina have granted bargained, sold & released and by these presents do grant bargain sell & release unto the said William Peden a certain tract or parcel of Land lying & being in Greenville South Carolina on a branch of Reedy River beginning at a Post oak corner from thence North East twenty four degrees thirty two Chains bounding upon land Surveyed for Michael Purkle to a Stake corner thence South East sixty six degrees thirteen chains to a Post oak corner thence South West twenty seven degrees thirteen chains to a Stone corner, and from thence to the beginning containing one acre be the same more or less together with all and singular the rights members hereditaments appertaining to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises above mentioned unto the said William Peden his heirs and assigns forever and I do hereby bind my self my heirs Executors and Administrators to warrant and forever defend all and singular the premises unto the said William Peden his heirs and assigns against myself and my heirs and against every Person Whome so ever Law fully claiming or to claim the same or any part thereof in witness my hand and seal this thirtieth day of November in the year of our Lord one thousand seven hundred & ninety seven, and in the twenty second year of the Independence of the United State of America

South Carolina Know all men by these Presents that I Benjamin Barton of Pendle to County in consideration of the sum of thirty pounds Sterling money to me paid by Frances Hally of the County of Greene aforesaid have granted Bargained sold Released and by these do grant bargain sell & Release unto the said Frances Hally all that tract or Parcel of Land lying and being in Greenville County aforesaid on a branch of the North fork of Saluda River the place where of the said Hally now Lives beginning on a chisnut running N 40. 00 to a hickory thence N 16. 00 to a hickory thence N 6. 00 40. 00 to a chisnut thence S 88. 9. 00 to the beginning containing one acre be the same more or less the said Land granted by a Patent to the said Benjamin Barton on Sixth day of February in the year one
