sum of twenty pounds to him in hand paid by the said Bolan Sutton the receipt
where of is here by acknowledge and him the Said Auguston Clayton fully
satis fyed there with and he hath given granted Bargained sold and
Confirmed unto the Said Bolan Sutton a small parcel or tract of Land
Supposed to be two hundred acres more or less being a parcel of eight
hundred and seventy two acres of Land granted by unto the said Auguston
Clayton by a grant bearing date the first day of July one thousand
seven hundred and Ninety two and is bound as follows and
