 It now all men by these presents that I William White of Greenville County in consideration of the sum of Twenty Pounds to me paid by William S Brown of the County of the said have granted Bargained sold & released by these presents do grant Bargain sell & Release unto the said William S Brown a plantation or parcel of Land lying & being in the County aforesaid on the waters of South Catawba River (on the North side of the same) beginning at a red oak Corner, (on the ridge Road where the County road crosses it) Arising thence S^o 38. W^o 24. Ch^t to a Black oak near said Browns line thence S^o 47 E with his line to his & Menick Heusing tons Corner & with Heusing tons line 45 Ch^t to a White oak near a branch thence up the various meanders of the branch to a pine near the Head of the branch the south side thence S^o 40 E. 8 Ch^t 5 Links to a Ches on Daniel Stoneys phers line thence N. 10. W. 20 Ch^t with line to a Chesnut his corner Thence to the Beginning containing by Estimation one Hundred acres be the same more or less being part of a tract of Land Granted patent bearing date May 6th 1790 containing Five hundred and seventy Four acres unto William Clayton & by him conveyed to me, Together with all & singular the Rights members Hereditaments and appertinances to the said premises belonging in any wise appertaining To have & to hold and singular the premises before mentioned unto the said William S Brown
