 James by a grant Baring date the first day of January

 Agnes being proven before Robert M. H. Esq. by the oath of John
 Morgan was presented and Recorded this 25 day of April 1799
 This Indenture made the fifth day of July in the year of
 our Lord one thousand seven hundred and ninety seven Between
 William Morgan of the State of South Carolina and County
 of Greenville of the one part and William Syres of the County
 and State aforesaid of the other part witnesseth that the
 said William Morgan for and in consideration of the sum
 of twenty pounds Sterling money to him in hand paid by
 the said William Syres the receipt whereof is hereby acknowledged
 the said William Morgan hath Bargain-
 ed and sold and by these presents doth bargain and sell
 unto the said William Syres a certain tract or parcel
 of Land containing one hundred acres be the same more or less
