

272 The following deed of conveyance from Asham Burkes to Richard Brasil being proven before Willey S. Brown Esq^r by the oath of David Hall was presented and recorded this 14th day of June 1799 State of South Carolina Know all men by these presents that Asham Burkes of Greenville County in consequence of the sum of fifty pounds to me paid by Richard Brasil of the County aforesaid have granted bargained sold & released and by these presents do Grant bargain sell and release unto the said Richard Brasil a plantation or tract of Land lying & being in the County aforesaid on S^e parolale River beginning at a Red oak in the fork of the River & Greens Creek about one Chain from the river Willey S. Browns course running thence S^o 25 W^o by the River to a post oak thence to a pine on David Halls Land thence N^o 70 W^o 11 Ch^o 30 Links to a pine thence N^o 60 W^o 7 Ch^o 11 to a chestnut Oak thence N^o 10 W^o 19 Ch^o 13 to the River to a Red oak thence N^o 60 E^o to Willey S. Browns line to a Stake thence S 39 E^o to a Red oak thence S^o 21 E^o 15 Ch^o 11 to a Black oak thence S 39 E^o to the beginning containing by Estimation one Hundred Acres but the same more or less being part of a tract granted by patent to Joseph Maxwell being sold state 5th December 1791 and by him conveyed to John Huddleston & by him conveyed William Laughlin sent to John Huddleston

267/3 By them to me on said tract is a shooe when is erected a Sull Mill together with all and singular the Rights maners Accoutments & appertinans to the said premises belonging or in any wise appertaining to have and to hold all and singular the premises before mentioned unto the said Richard Brasil his heirs & assigns forever & he here by bind myself my heirs Executors and Administrators to warrant and defend all & singular the said premises unto the said Richard Brasil his heirs & assigns against myself and my heirs & against every person wheresoever Lawfully claiming or to claim the same or any part thereof In witness whereof I have hereunto set my hand & seal This Twentysfirst day of April in the year of our Lord one thousand seven hundred and Ninety eight and Twentys second year of American Independence In presence of signed sealed and delivered in presence of John Davis Jun^r & James B. 273 The following deed of conveyance from John Davidson to William Wood being proven before Rubin Barretto Esq^r by the oath of Alexander Anderson was presented and recorded this 14th day of June 1799 - This Indenture made this first day of May in the year of our Lord one thousand seven hundred and Ninety four between John Davidson of Greenville and State of S^e Carolina of the one the one part and William Wood in the County and State aforesaid of the other part witnesseth that for and in consideration of the sum of Ten pounds to him in hand paid by said William Wood before the sealing and delivering of these presents the receipt hereof is hereby fully acknowledged both Bargained and sold and by these presents doth grant bargain and sell Alien release confirm and convey unto the
