312 The following Instrument of writing from Coffa Walling to Michael Walling being proven before David Goodell Esq. by the oath of Edward Walling was presented and Recorded this 29th day of July 1799 State of S. Carolina Greenville County

To all to whom these presents shall come Whereas Michael Walden and Eve his wife have this day by mutual consent agreed to separate from each other bed and board and whereas the said Michael hath given unto his said (late) wife the following articles of property for her dividend of his Estate for her separate use and maintenance in order to do her justice and not hereafter be subject to any trouble action suit or demand by or from her or to her use or from any other person or persons what so ever for her or in her name (To wit) Four Cows two calves three yearlings one two year old Steer and all his house hold furniture (to wit) all beds and there furniture and appurtenances and all other House hold & Kitchen furniture of every kind, Now Know all men by these presents that I Eve Walden (late) wife of the said Michael Walden for & in consideration of the above mentioned articles & another property (to wit) four Cows and two calves three year old Cows kind and one two year old Steer all the beds which we had and there furniture and appurtenances and all there other House hold & Kitchen furniture of every kind which I have this day rec^d have & by these presents do acquit Release and for ever exonerate the said Michael from me my bed and board and from all and every action suit Dower & title of dower Requests demands Interruptions & and Motestations and also all Estate Rights & titles what so ever allowing and hereby maintaining to him the full and free disposition of himself and his present Estate Rights Interests & Titles or any other or others which he may here after acquire by marriage or other wife in as full free and comple manner as if I had never been his wife Reserving to myself the raising and bringing up our youngest child named as above without any

313 This Indenture made this 22nd day of August in the year of our Lord One thousand seven hundred and ninety five Between William Austin of the County and State aforesaid of the one part and Amos Richardson of the same County & State aforesaid of the other part It is agreed that the said William Austin for and in consideration of the sum of Twenty five pounds Sterling money to him in hand paid by the said Amos Richardson at and before the sealing and delivery of these presents the Receipt of which the said William Austin doth acknowledge and free of and of and from every Every part and parcel thereof doth acquit and discharge the Amos Richardson his Heirs and assigns and their Divis & there good causes and consideration hereunto moving have granted Bargained sold all and conveyed and confirmed and by these presents doth grant Bargain sell alien in full and confirmed unto the said Amos Richardson his Heirs and assigns for ever part of a certain tract of Land containing five hundred and thirty acres originally granted to Abram Markley and Signie By this excellent William Moultrie on the sixth day of November in the year 1786 situate in the district of ninety six on the Waters of Guider's Creek on the south side of Grays Branch Beginning at a Black Oak corner thence running E. to a Conditional corner on a pine thence a North line a Conditional line to the mouth of the Branch including the Spring from thence a West course up Grays Branch to the road - from thence a west course to the open line and corner to a stake from thence a south course to the beginning corner including one hundred
