 Vos at or before the sealing and delivery of these presents
 do Grant Bargain sell alien Release Convey and
 confirm unto the said Andrew Vos (in his actual possession
 now being by Virtue of a Bargain and Sale to him there of
 made for one whole Year by Indenture of Lease bearing date
 the day next before the of the date of these presents and by
 force of the Statutes for transferring uses in to possession)
 and to his heirs and assigns forever all that Plantation or tracts
 of Land containing three Hundred acres situate in the District
 of Ninety six on Saluda River in the State aforesaid and hath
 such shape Form and marks as are represented in a plat
 thereof annexed to the original Grant to the said Job
