 thence N.W. 75 to a Red Oak, Anthony's corner, thence S.W. 48 to a  
 Red Oak on the Road thence down said Road S.E. to a Post  
 Oak on the Old Road thence N.E. 40 to a Post Oak on the S. Road  
 thence down said Road with its meanders to the beginning on the creek  
 Together with all and singular the rights and members hereditaments and  
 appurtenances to the Premises, belonging or in any wise incident or ap-  
 pertaining; To have and to hold all and singular the Premises before
