in consideration of one hundred dollars to me paid by Ipe  
Parker of the State and District have granted bargained sold and  
Released, and by these presents do grant bargain sell and Release  
unto the said Ipe Parker part of a Tract of land supposed to be  
originally granted to W<sup>m</sup> Floyd, thence conveyed to W<sup>m</sup> Story, thence  
to Francis Brown, now from said Brown to s<sup>r</sup> Parker, That part of  
the tract that lies on the North side of the north fork of Horse Creek  
the water of Keedy River in the District aforesaid beginning on a  
Fishe running on the original line N. 86<sup>th</sup> 10<sup>th</sup> to a Sour wood, thence  
S. 8<sup>th</sup> 70 to a Sweet gum, thence down S<sup>th</sup> horse Creek S. 65<sup>th</sup> E. 21<sup>th</sup> 57<sup>th</sup> to a  
Poplar, thence N. 61<sup>th</sup> E. 10<sup>th</sup> 50 to a hickory, then N. 5<sup>th</sup> E. 3<sup>th</sup> to a post oak, then  
to the beginning, supposed to be Fifty acres more or less. Together with  
all & singular the Rights, members, hereditaments and appurtenances to the  
said Premises, belonging or in any wise incident or appertaining
