Know all men by these Presents that I David Miller of Greenville District a State aforesaid in consideration of <sup>the sum of</sup> eight hundred and sixty dollars to me in hand paid by James M. David of the State and Districts aforesaid, have granted bargained sold & Released and by these Presents do grant bargain sell and Release unto the said James M. David all that Plantation or Tract of land containing five hundred and five acres (be the same more or less) situate in Greenville District lying on Beavardam Creek, being the North fork of Mountain Creek waters of Saluda River. Beginning on a line 3+ on said Creek running thence S 80 E 39 ch. to a hickory 3+ bounding on Capt. George Grace, thence N 10 E 48 ch. to a dogwood 3+ lying bounding on Wm Scott's land, thence N 60 W 16 ch. to a White Oak 3+ bounding on Capt. Wm Scott's land, thence N 2 E 27 ch. on said Scott's line to a Red Oak 3+ thence N 7 E 24 ch. on the aforesaid Scott's line to a Red oak 3+, thence N 10 E 9 ch. to a Stake 3+, bounding on David Duvee thence N 80 W 27 ch. to a Rock 3+ near a branch, thence down the meanders of said branch about 30 ch. to its confluence with the Beavardam Creek, thence down the meanders of said Creek 26 chains to a Stake 3+, thence S 75 W 5 ch. to a hickory 3+ bounding on Joseph Cokers land, thence N 80 W 37 on said Cokers line to a Red oak 3+ thence S 10 W 22 ch. 50 to a Stake 3+ bounding on Drury Morris' land thence S 56 E 27 to a hickory 3+ bounding on Benjamin Roper's land at the head of a branch, thence down said branch to a poplar 3+ on the Beavardam Creek thence down the meanders of said creek to the beginning (being part of a tract of 640 acres of land originally granted to David Humphries on the fifteenth day of October 1784 as to the said Grant recorded in Grant book AAAA..

(Page 172) Together with all and singular the rights members hereditaments and appurtenances to the said Premises belonging or in any wise incident or appertaining To have and to hold all and singular the premises before mentioned unto the said James M. David his heirs and assigns forever. And I do hereby bind myself and my heirs Executors and administrators to warrant and forese all and singular the Premises above mentioned unto the said James M. David his heirs and assigns against myself and my heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof.
