117 1/2 feet to a stake 3x thence South 15 1/2 W. 140 feet to a stake 3x thence N 74 1/2 W
117 1/2 feet to a stake, thence N 15 1/2 E 140 feet to the beginning, & the whole lots number
are above mentioned & containing by estimation one acre of land be the same more or less,
