Bargained sold released conveyed and confirmed and by these presents do
grant bargain sell release convey and confirm unto the said Charles Sutherland
his heirs and assigns two fifths parts of all that plantation tract or parcel
of land containing one hundred acres being the same more or less situate
in Greenville district aforesaid on a branch of the North fork of Sa-
luda River originally granted to Benjamin Barton by grant be-
= aring date the sixth day of February one thousand seven hundred and
eighty six and by Barton was conveyed to our deceased father Fran-
= cis Holley under whom we claim as legatees the said tract of land.
Run as follows; that is to say beginning on a chestnut three & forty
Chains to a Hickory three North fifteen chains to a Hickory three
North six degrees west forty chains to a Chestnut three south nine
degrees west thirty seven chains to the beginning the whole tract being one
Hundred acres more or less as aforesaid two fifth part of which we
have by convey as aforesaid together with all and singular the Right
numbers hereditaments and appurtenances to the said premises belonging
or in any wise incident or appertaining to have and to hold
all and singular the said two fifth parts of the said premises unto
the said Charles Sutherland his heirs and assigns for ever and we do
hereby for our selves and heirs Executors and administrators jointly and
severally bind our selves to warrant and for ever defend the aforesaid
mentioned premises unto the said Charles Sutherland his heirs and assigns
against our selves our heirs Executors and administrators and against
every other person or persons whom soever lawfully claiming or
to claim the same or any part thereof In witness whereof
