George Salmon of Greenville District and State aforesaid for and  
In consideration of the sum of One Thousand Eight hundred dollars  
to Ezekiel J. Salmon of the State and district aforesaid in hand  
well and truly paid by William H. Salmon of the same place the  
Receipt Whereof is hereby acknowledged I have Granted bargained  
Sold released conveyed and confirmed and by these presents do grant  
Bargain sell release convey and confirm unto the said William  
H. Salmon his heirs or assigns a plantation tract or parcel of Land  
containing six hundred and twenty eight acres be the same more  
or less situate in Greenville District aforesaid on the North East side of  
the North fork of Saluda River and running as follows (viz) Beginning  
on a stream on the Bank of said River at the mouth of an old ditch  
thence North fifty six degrees East Twenty nine chains to a post oak at the  
mouth of a ditch cut by Barton thence North Twenty one degrees East  
Eighteen chains to a Chestnut on a branch thence up the straitest fork there  
to the first fork below a school house thence up the left fork of said branch  
to a marked White oak and stck across the road thence North thirty three  
degrees West Twenty chains to Roddens red oak corner thence the same  
course thirty three chains to Roddens Spanish oak corner thence North  
Seventy five degrees West fifteen chains to a maple on a branch thence down said  
branch to a Mountain oak couches corner thence South Thirty one and a half  
Degrees East Twenty one chains to a Mountain oak Mapes corner thence both  
Twenty degrees West forty five chains and fifty links to a post oak Sallys corner
