W. to the beginning corner so as to include twenty nine acres of land — Together with all and singular the rights, members, hundelments and appurtenances unto the said premises belonging or in any wise incident or appertaining to the same and to hold all and singular the premises before mentioned to the said John Atkinson and I do hereby bind my self, my heirs Executors and Administrators to warrant and forever defend all and singular the premises before mentioned unto the said John Atkinson against myself, my heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof in witness whereof I have hereunto set my hand & seal this twenty third day of September in the year of our Lord one thousand eight hundred and sixteen.
