 dollars for which he holds our notes due the first day of May next now know all men by
 this presents that we the said Thomas Horn & Elizabeth Horn in order to secure the payment of
 said notes as well as in consideration of one dollar to us in hand paid have bargained
 sold & released and by these presents do bargain sell & release unto the said Zion Goodlett
 two negro boys to wit one named Prince a boy about twelve years old and one named
 Dick a boy about seven years old To Have and to hold the said negroes to him & his heirs
 forever provided nevertheless that if the said Thomas Horn and Elizabeth Horn shall
 well and truly pay and deliver all such sum of money which may be found run-
 -ning in their hands of the Estate of William Hugh. dec'd to the distributees of said Estate when
 a settlement is made of the same according to law, viz, all except the portion which Elizabeth
 Horn is intitled to as the widow of said dec'd then the above bill of sale or mortgage to
 be void & of none effect otherwise to remain in full force & virtue Intestimony whereof we
 have here unto set our hands & seals this first day of May 1826. signed sealed and acknow-
