

 and district have granted bargained sold and released and by these pre-
 sents do grant bargain sell and release a part of a tract of land
 originally granted to Lemuel J. Atton together with a part of a tract origin-
 ally granted to David Lister lying on both sides of the Spartanburgh road
 on the waters of Rich Land Creek in the District and State aforesaid have-
 ing such bounds marked as follows viz Beginning at a Stake 3x near a red
 oak on the Spartanburgh road thence S. 80 W. 19. 50 ch. up said road to a Stake 3x on the
 road thence S. 69. E. 14. 40 ch. to a black 3x thence S. 35. W. 7 ch. to a Stake 3x thence S. 50.
 E. 28. Ch to a red oak 3x thence N. 45. E. 21. 20. ch. to an ash 3x on a branch thence up the
 meander of said branch to a white oak 3x 10 ch. thence N. 79. W. 16. 25. ch. to a red oak
 3x on the Spartanburgh road thence down said road N. 76. E. 5. 50. ch. to a red

 the said David Henning his heirs and assigns against myself my heirs
