

Hill all and singular the said goods Chattles personal Estate &c And other the premises to the said James Willis his heirs Executors administrators &c against me the said R. Hill my Executors administrators &c and all and every other person & persons whomsoever shall and will warrant & forever defend by these presents of all and singular which said goods Chattles personal Estate & other the premises I the said R. Hill have put the said J. Willis in full possession by delivering to him one feather bed and furniture at the time of the sealing and delivery of these presents in the name of the whole premises hereby granted In witness hereof I have hereunto set my hand and affixed my seal this 18th Decr. 1826 signed sealed & delivered in the presence of us.
