 the same to the beginning on the poplar it being part of a tract of
 land granted unto Col. Thomas Taylor for 577 acres and granted from
 him to Joseph Smith sen. and granted from him to his son David
 Smith by a deed of gift and hath such boundaries as a bore mentioned
 and for the consideration of the sum of three hundred dollars to
 me in hand paid by Paschal High Together with all and singular
 the above mentioned premises whereon David Smith now resides
 unto Paschal High his heirs and assigns forever and I do here by bind
 my self my heirs and assigns to warrant and for ever defend the said
 premises unto the said Paschal High his heirs and assigns for ever against
 my self my heirs and assigns and against all other persons to claim or
