 five hundred dollars to me in hand paid by Allan R. Parkins of the said
 district and State, the receipt whereof is hereby acknowledged Have granted
 bargained, sold and released and by these presents do grant, bargain
 sell and release unto the said Allan R. Parkins all my Right title inter-
 -est, claim and estate of inheritance to which I now may be entitled
 as one of the heirs and legates of my father Jesse Carter deceased,
 in all the land and real Estates that may have descended from my father
 to me Consisting of one fourth part of four hundred and eighty five
 acres be the same more or less which has never been measured off, in
 parcels to each heir but is included in the deed from My brother
 James M. Carter and my Mother Lydia Hornbuckle to Garland Walker
 bearing date the 1st day of August 1819. wherein and whereby all my
 right title and interest and estate was intended to be conveyed to the
 said Garland Walker by my said brother James M. and my Mother as
 my lawful Guardians and which act and deed I now ratify and
 confirm fully as I could have done had I been of full age
 at that time and acting for my self and by reference to that deed
 a description of the tract a part of which I now release
