W. to the beginning containing two hundred and fifty five acres be the same more or less together with all and singular the rights numbers, hereditaments, to the said premises belonging or in anywise incident or appertaining to have and to hold all & singular the said premises before mentioned unto the said James Harper his heirs & assigns forever and I do hereby bind myself my heirs Executors and administrators to warrant & forever defend all and singular the said premises unto the said James Harper his heirs and assigns against my self my heirs and Executors In witness whereof I have hereunto set my hand and seal this Eleventh of March in the year of our Lord one thousand eight hundred and twenty seven signed sealed Delivered in presence of
